Christopher Giancarlo, a public supporter of the swaps market reforms passed by Congress in Title VII of the Dodd-Frank Act, namely clearing swaps through central counterparties, reporting swaps to trade repositories and executing swaps transactions on regulated trading platforms. The author supports the CFTC s implementation of the first two reforms, but is critical of the CFTC s implementation of the third, as explained in this White Paper. This paper begins with a broad overview of the complex structure of the global swaps market. It then reviews the clear legislative provisions of Title VII of the Dodd-Frank Act. Next, it reviews in detail the Commission s flawed implementation of the Dodd-Frank Act s swaps trading provisions. This paper asserts that there is a fundamental mismatch between the CFTC s swaps trading regulatory framework...
